

NOTICE OF AGREED DISMISSAL





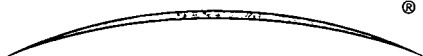
