

Motion for an Extension of Time

Pursuant to Rules 207 and 240 of the South Carolina Appellate Court Rules, Appellant Kwaun Ka'Shawn Peay requests a thirty (30) day extension of time to order the transcript for the above-captioned matter. This is the first request for an extension of this deadline.

Undersigned counsel was retained only to handle the post-conviction relief matter in common pleas court and does not handle appellate matters. Appellant has stated that he cannot currently afford to retain any counsel on his appeal and would like representation from the Office of Appellate Defense. Applicant submitted an Application of Indigency to Appellate Defense but failed to have it notarized and failed to answer every question. Appellant needs additional time to re-submit his application so that he may be screened and have counsel appointed if he is eligible.

Therefore, counsel respectfully moves this Court for a thirty (30) day extension of time to order the transcript for the above-captioned matter. This would extend the deadline until February 16, 2014. **Counsel asks that the current deadline be held in abeyance pending the Court's consideration and resolution of this motion.**


