
PETITION TO DISMISS APPEAL



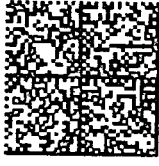
