Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Eric Mance v. State in the Supreme Court on January 3, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Adam Lee Berard v. State in the Supreme Court on December 31, 2014. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Curtis J. Simms in the Supreme Court on December 27, 2013. Counsel filed the Anders brief of appellant and designation of matter in the case of State v. Jimmy Lee Duncan in the Court of Appeals on December 17, 2013. Counsel attended a motion for reconsideration of sentence hearing in the case of State v. Luther Norris on December 5, 2013 in Kershaw County before the Honorable Clifton Newman. This Court ordered Mr. Norris's case remanded for disposition of the pending motion. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Orlando Smith v. State in the Court of Appeals on November 27, 2013. Counsel filed the return to petition for writ of certiorari in the case of Horace Abney, Jr. v. State in the Supreme Court on November


25, 2013. Counsel filed brief of petitioner in the case of Michael Gonzales v. State on November 22, 2013 in the Court of Appeals.

3. This request is made in good faith, and not for purposes of delay.


4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.




