MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE
PETITION FOR WRIT OF CERTIORARI

Counsel respectfully requests a thirty day extension in which to file the petition for writ of certiorari in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

1. The petition for writ of certiorari and appendix is due to be served and filed with the Court today.

On December 6, 2013, counsel filed a petition for writ of certiorari and accompanying appendix in Corey Peterson v. State with this Court. On December 2, 2013, counsel filed a petition for writ of certiorari and accompanying appendix in Richard Simmons v. State with this Court. On November 26, 2013, counsel filed the brief of appellant and record on appeal in State v. Russell Edward Nix with the Court of Appeals. On November 22, 2013, counsel filed the brief of appellant and record on appeal in State v. Charles Davis with the Court of Appeals. On November 22, 2013, counsel filed the brief of appellant and record on appeal in State v. Anthony Riggins with the Court of Appeals. On November 18, 2013, counsel filed the initial brief of appellant and designation of matter in State v. Phillip Monroe with the Court of Appeals. On November 12, 2013, counsel filed the initial brief of appellant and designation of matter in State v. Tiphani Marie Parkhurst with the Court of Appeals.


4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload




