That GARY REECE THOMPSON, JR. did in Greenville County, between October 11, 2007 and May 13, 2010, willfully and unlawfully commit the crime of Criminal Sexual Conduct with a Minor in the First Degree by engaging in a sexual battery with the victim R.M., who was less than sixteen (16) years of age and the Defendant has previously been convicted of, pled guilty or nolo contendere to, or adjudicated delinquent for an offense listed under 23-03-0430 ( c) and/or has been ordered to be included on the sex offender registry. This is in violation of §16-3-655(A)(2) of the South Carolina Code of Laws (1976) as amended.


