## ISSUES TO BE HEARD ON BRIEF

1. That on 2/11/2007 Officer Charles Campbell took it upon himself to obtain two (2) invalid arrest warrants against me and forged the municipal court judge name and my name on these inactive arrest warrants. Please the back of both warrants where the judge did not signed his name as endorsement of the signature under section 17-13-140. Statutory requirement.
2. That on 1/7/2014, my attorney Lara M. Carly wrote me and informed me that she could not locate any jury dockets from trial during the year of 2007, when my trial took place.
3. The Public Index from the Lancaster County Clerk of Court have prove that I was not indicted by a Grand Jury on February 7, 2007 nor was the municipal court judge assigned to these invalid arrest warrants that was obtain by Officer Charles Campbell which he had no legal authority to sign the name of a judge of records.
