




NOTICE OF APPEAL



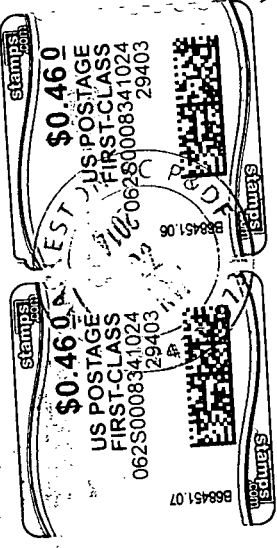
