
NOTICE OF APPEAL

Appellants, Goodwill Industries of Lower SC, Employer, and PA Manufacturers Association Insurance Company, Carrier, appeal the order of the Appellate Panel of the South Carolina Workers' Compensation dated January 10, 2013, on the following grounds:

- I. THE APPELLATE PANEL ERRED IN FINDING THAT CLAIMANT'S NECK PROBLEMS ARE CAUSALLY RELATED TO HIS INJURY BY ACCIDENT ON JULY 4, 2012 UNDER § 42-1-160.
- II. THE APPELLATE PANEL ERRED IN FAILING TO REQUIRE CLAIMANT TO PROVIDE MEDICAL OPINION EVIDENCE THAT THE PRE-EXISTING DEGENERATIVE CONDITION IN CLAIMANT'S CERVICAL SPINE WAS AGGRAVATED BY THE WORK ACCIDENT ON JULY 4, 2012 UNDER §42-9-35.
- III. THE APPELLATE PANEL ERRED IN FINDING THAT CLAIMANT IS ENTITLED TO MEDICAL TREATMENT FOR THE CERVICAL SPINE UNDER § 42-15-60.


