




**NOTICE OF VOLUNTARY DISMISSAL**



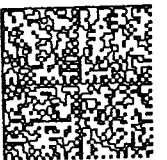
