Dear Mr. Shearouse and Ms. Kitchings:

The above-referenced case is currently pending before the Supreme Court on certiorari proceedings, which have been held in abeyance pending circuit court approval of the proposed class action settlement. After sending notice of the settlement to all class members, the circuit court held a final approval hearing on October 18, 2013. No class member filed an objection to the proposed settlement. The circuit court approved the settlement by order dated and filed October 23, 2013, retaining jurisdiction to enforce the settlement and resolve any questions that might arise during final consummation of the settlement. We are expecting the final document which will consummate the settlement to be filed today or Monday, February 3rd.

Upon final consummation of the settlement, we will advise both appellate courts. At that time, we would anticipate filing a consent motion for dismissal of the appeal. Please advise if you need anything further from us at this time.



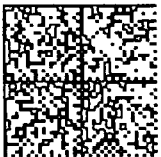
