

NOTICE OF APPEAL

North Pleasant, LLC and Vanguard Development, LLC appeal the orders of the Honorable Roger M. Young dated December 18, 2012 and February 26, 2012 granting summary judgment as to Appellants' claim for violation of the S.C. Unfair Trade Practices Act and as to all claims against Edward D. Beach and the order of the Honorable Roger M. Young granting a directed verdict to Respondent South Carolina Coastal Conservation League as to the remaining claims. The latter was issued in a verbal order from the bench on December 11, 2013 and was repeated in a form written order dated December 17, 2013. Respondents filed a motion pursuant to Rule 59(e) and that motion was denied by the Honorable Roger M. Young on January 14, 2014, of which Appellants received written notice on January 21, 2014.





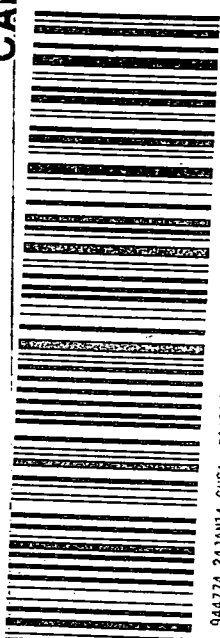
