**Appellants' Motion to Allow J. Christopher Clark to
Withdraw as Counsel of Record**

Pursuant to Rules 264(b) of the South Carolina Appellate Court Rules, Appellants TriStar Investors, Inc., Minerva Realty, LLC, and Angeline Johnson ("Appellants") request that this Court allow J. Christopher Clark to withdraw as counsel of record for Appellants. The basis for this motion is that J. Christopher Clark has left Nelson Mullins and no longer represents Appellants in this appeal.

Appellants have been represented from the outset of this appeal by Susan MacDonald, Michael J. Anzelmo, and L. Morgan Martin. Mrs. MacDonald, Mr. Anzelmo, and Mr. Martin will continue representation of Appellants until final disposition. The withdrawal of Mr. Clark will not impact representation of Appellants, prejudice Appellants in any manner, or delay this appeal.

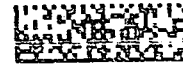
