RE: Inability to get any information from the Worker's Compensation Commission about the December 1997 hearing that Commissioner Huffstetler retried and substituted against me at the September 3, 2007 hearing instead of the intended claim.

Dear Ms. Kitchings:

Since Commissioner Huffstetler retried a December 1997 hearing against me and Judge Lee agreed with him in her Orders, I have tried to get a copy of the proceedings of this hearing. I was not at the hearing and I only know bits and pieces about what went on, but I do know that this was the case that Commissioner Huffstetler retried against me.

On or about December 23 or 24, 2013, I sent a certified mail to the Worker's Compensation Commissioner inquiring about this hearing because I would like to have the transcript and copy of the proceedings and the decision that was made about my right shoulder. I also need to know exactly what went on so that I can be in a better position to tell the Court all what went on. I believed it also contained information about Attorney Thomas M. White and what he did to me with my January 23, 1995, claim against Trident Hospital. I need to include it in my Designation of Matter because it has a lot of bearing on what is happening to me in the above case. I received the green card back from the Worker's Compensation Commission but I have not had any correspondence or anything from the Worker's Compensation Commissioner. I don't know who the transcriptionist was at that time or from what company that she was from so that I can order the transcript.

I am afraid to go to the worker's compensation commission to inquire about it because of how I was treated in the past by Commissioner Huffstetler. I even was afraid to file my claim for my 2010 injury there. I don't know how to go about getting a copy of the proceedings from this December 1997 hearing. Commissioner Huffstetler and the opposing attorneys had access to all of my files and I did not. The single hearing commissioner is believed to have been Commissioner Holly S. Atkins. She did not tell me that she was the single hearing Commissioner when she told me to refile my January 1995 claim against Trident Hospital in 2000 at the hearing concerning my back injury of October of 1997.

In addition, I am still trying to get my transcript where I was deposed in August of 1997 with Attorney Alison Carter for my Designation of Matter. Enclosed is a copy of the letter sent to the Worker's Compensation Commission inquiring about the December 1997 hearing.

There was a Worker's Compensation Proceeding held in December of 1997 which concerned Gertrude Shiver and Trident Hospital. I wasn't present at the hearing, but I believe that Holly S. Atkins was the presiding Worker Compensation Commissioner at that time.
