
Dear Dalvin:

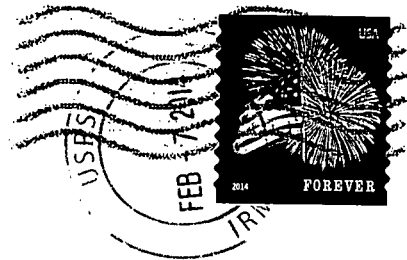
