
Appellate Court Rules. The parties reserve their rights under those rules to make later motions regarding certification, consolidation, and scheduling.

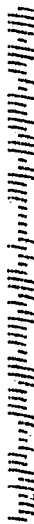
