

If you have any questions in this regard please do not hesitate to contact me.

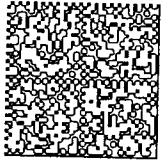
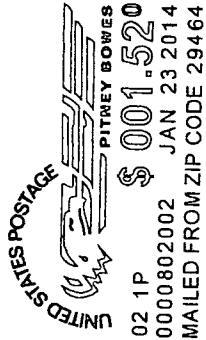
