At a Court of General Sessions, convened on **NOV 22 2011** the Grand Jurors of Greenville
County present upon their oath:

COUNT I — MURDER

That WALKER MANNING HUGHES did in Greenville County, on or about the 8th day of April 2011,
unlawfully and with malice aforethought kill [REDACTED] by means of beating her with a blunt object, and
that **KAREN HUGHES** died as a proximate result thereof. This is in violation of §16-3-10 of the South Carolina
Code of Laws (1976) as amended.

COUNT II — POSSESSION OF A WEAPON DURING THE COMMISSION OF A VIOLENT CRIME

That WALKER MANNING HUGHES did in Greenville County, on or about the 8th day of April 2011, possess
or visibly display a blunt object during the commission or attempted commission of a violent crime, to wit:
MURDER. This is in violation of §16-23-490 of the South Carolina Code of Laws (1976) as amended.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.


