In response to the deficiencies in the *NOTICE OF APPEAL* which are:

- *REQUIRED FILING FEE OF 100 DOLLARS;*
- *A COPY OF THE PROOF OF SERVICE OF THE NOTICE OF APPEAL ON THE ADMINISTRATIVE LAW COURT;*

As to the first, Appellant is indigent and does not have the required funds to pay the required filing fee. Appellant does not have any way to receive the required amount. Appellant has requested the proper forms to prove this indigency status with SCDC. It takes the financial office in Columbia roughly *EIGHTEEN (18)* days to return these forms. Appellant requests for such a time frame in order to receive them and file motion of application to proceed on Appeal as *IN FORMA PAUPERIS*.

As to the second, Appellant must request a copy of the *CERTIFICATE OF SERVICE* from the Administrative Law Court that was filed with the *NOTICE OF APPEAL* or request the Administrative Law Court to forward a copy to the Court of Appeals. Appellant has no access to a copy machine and paper in the Special Management Unit is disturbed to inmates in small amounts. Due to this, Appellant filed the *NOTICE OF APPEAL* with SCDC and the Administrative Law Court around the beginning of January 2014. When paper was distributed to inmates again, Appellant filed a *NOTICE OF APPEAL* with the Court of Appeals and SCDC. Each *NOTICE OF APPEAL* was exact hand-written copies. Therefore, Appellant would ask for enough time to receive a copy of the *CERTIFICATE OF SERVICE* in the *NOTICE OF APPEAL* from the Administrative Law Court.

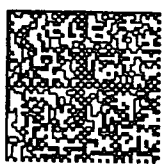

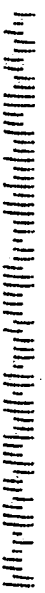
