Per your request, I have attached a copy of the circuit court's order on Motion to Withdraw the Motion for a New Trial. Pursuant to Rule 245(a) (SCACR), I would like the Court to exercise original jurisdiction and hear arguments in Plaintiff's Motion for a New Trial, Motion to Alter/Amend Judgment not heard in almost one year. I would like the Court to consider other relief sought in the Emergency Petition as well. I would like to comply with Rule 240 (SCACR) stating the grounds thereof and provide a memorandum with citation of authorities in support of the motion. *However*, the recent escalation of law enforcement involvement necessitates my urgent request for at least a temporary injunction and/or protective order as the Court deems appropriate until such time as the matter on appeal may be heard.
