

**PETITIONER'S MOTION
FOR EXTENSION OF TIME**

THIS MATTER comes before the Court by way of an appeal from a Post-Conviction Relief Order. The Petition for Writ of Certiorari is due for filing on today's date. I have a murder trial beginning on today's date and have been tied up with pre-trial matters relating to this trial. 



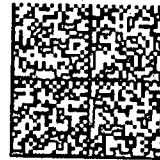
