

On Monday, February 03, 2014, counsel had an oral argument in the South Carolina Court of Appeals in the case of State v. Cesar Portillo. On Monday, January 27, 2014, counsel filed the Anders brief of appellant and record on appeal in the case of State v. Sincere J. Owens. On Wednesday, January 15, 2014, counsel filed the Anders brief of appellant and record on appeal in the case of State v. Charlie Belser. On Monday, January 13, 2014, counsel filed the petition for writ of certiorari and accompanying appendix in the case of Duval M. Cooper v. State. On Friday, January 10, 2014, counsel filed the initial brief of appellant and designation of matter in the case of State v. William Edward Price. On Friday, December 27, 2013, counsel filed the petition for writ of certiorari and accompanying appendix In the Interest of Justin B., a minor under the age of seventeen in the United States Supreme Court.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.


