

The Defendant's Motion to Dismiss came before this Court on November 15, 2013. The Plaintiff, Gary Steven Scott, appeared pro se. S. Ashley Gwin, Esquire, appeared on behalf of the above named Defendants.

The Plaintiff's Complaint alleges that the Defendant violated his right to freedom of religion under the 1st Amendment of the United States Constitution. The Plaintiff claims that employees of the South Carolina Department of Corrections brought his breakfast too late so that he could not consume the breakfast before he began fasting for Ramadan. The Defendant filed its Motion to Dismiss citing Rules 4, 12(b)(1), 12(b)(2), 12(b)(3), 12(b)(4), 12(b)(5), and 12(b)(6) of the South Carolina Rules of Civil Procedure.

The Defendant's Motion to Dismiss should be granted because this action involves a federal question that should be brought in the federal courts. This Court is not the proper forum for such claims.

It is HEREBY ORDERED that the Defendant's Motion to Dismiss is GRANTED. This ends the case.
