Dear Mr. Shearouse,

I am the Applicant in the above-captioned matter. On January 23, 2014 Applicant became aware that his Application for post conviction relief (PCR) became final via a motion filed by appointed Counsel entitled Motion To Vacate Disposition and Reopen Proceedings. A hearing was held on the motion on Feb. 21, 2014.

At the hearing Counsel for the Applicant gave him a copy of the Final order.

Applicant has asked Counsel to file a Rule 59(c) Motion to Alter or Amend Judgment so that the record will reflect the following points:

1) Did the Respondent waive the defenses of statute of limitations and successiveness pursuant to Rule 8 SCRPC for failing to file them in a timely fashion in accord with Rule 12 SCRPC?

The Applicant has argued this legal principal in a motion entitled Motion For Judgment By Default filed with the Greenville Clerk of Courts office on April 5, 2013 and again in a motion entitled Reply filed May 15, 2013.

The Applicant would ask the Court to please advise counsel of the situation to ensure the issue is maintained for Appellate review.

Furthermore, the Applicant wishes the Court to provide him with the address of whom he must write to request copies of the hearing transcripts that took place on June 20, 2013, August 30, 2013 and Feb. 21, 2014.

Finally the Applicant ask the Court to please grant him a stay of the proceedings until the motion can be filed or to appoint a set time in which it must be completed.

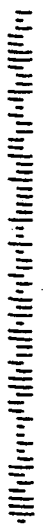

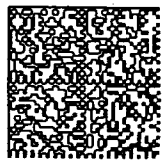
