Supreme Court as ordered by Paul De by Clerk Sherouse for Court to let them know to 59(B) was filed on time & to get a copy from Deane County Clerk Smith, because their staff Mr. Hudson refuse to allow me to access my 2-legal bags in Prison, from that what Sherouse wants, so they can order Clerk Smith to get the 59(B) motion of appeal #12-531 heard. I'll get released in 14 days to Hospital to see 14 Doctors. To fix broken bones, hernia, bleeding inside, replaced hip, neck, back, & collect money owed me by State 89K for 16 1/2 years false imprisonment. (Please get out from prison)

I sent this Court filing with 10-14 form to debit my wages fund 394 to create a record of its filing, Warden Padula has mail staff & guards to give him all my mails & request to staff to be read, & if it has anything in them about me moved out, death threats in President Bush 662 516 6 Feb. Fisher to Padula, Santoro, Ormunt, & held in his appeal states with forged warrants, & beating Padula destroying my mail, demand of medical & dental care to food, & 30 my number & Employee to call by 7 Deane deputies are to ruin reputation he does not allow it out nor Sgt. Ormunt & his staff. No to my lawyers see Att. General to stop his arrest & Ormunt & Santoro & stop my release because of the Re election Nov 30 & others up coming raised in appeal. 2. Daniel Murphy contacted 35 others. My friends filed by legal complaints Padula & Ormunt Dec 23 06 to Civil Penal Inspector to stop Federal Inmate, Privatized Fed judges Herby, Clarr & 4th Circuit 3- Fed Judges & Webster & Anderson. In appeal mail given to Judge S.C. Sup. Court & others to get court orders & arrests started.

3. Padula & Sgt. Ormunt fail to use 106 form as required (34A)

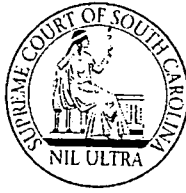

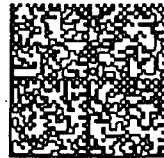
