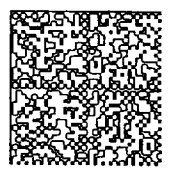

I am wanting A retrail on my safe cracking charge That I was snowed into Taking The day I went To court. My Lawyer, (Jennifer Davis) Told me For over A year of sitting In The county jail That I was ready And approved For The Bethel House program, Not 10 years violent time. I told my lawyer I Am not A violent person And I never want Any thing violent. I was Also Told over And over I Have no new charges. The Day of court 15 months later now There is A new charge. I did not understand This violent or no violent charges. I know my burglaries Are violent 65 because of The 3 strikes. I took The last minute safe cracking charge Thinking I was getting out of jail, Not Prison. This last minute thrown in charge has made my Time All violent To The department of corrections. My Lawyer says on Page 84 Line 5-9 she Had no Idea of The Time That I was given. My lawyer Thinks and Told me safe cracking — next Page

only becomes violent over 8 years of Time. Well I got 10 years and safe cracking is Automatic violent in this state. My lawyer had no idea how severe this new charge was going to be to me. IF my lawyer does not understand This new charge, then how am I to know? Also my pictures In the discovery material would have showed This was no safe, the police call it A wall cabinet with nothing missing and the police pictures show this cabinet is home made and has no locking mechanism to even lock the door. I did not get these pictures or my discovery material untill after I had Been sentenced. This discovery material would have changed my whole case. I would never in A million years go to court on A charge that could get me violent 85 Time. My lawyer AFTER over A year of dealing with me knew I wanted no violent time, peroid. I have now learned there is A non Violent 85 time, 65 violent or Non violent time. These Are other times I could have went For had I knew about them.

I would have went to trail on this thrown in safe cracking charge had I know how severe this new charge was going to be on me. I am asking the Supreme Court of South Carolina to look at my court transcripts and help me get back into court and get this violent time removed from my sentence.
