
Inmate appeals an issue related to his custody classification.


Thus this appeal must be dismissed under SCALC Rule 62 for failure to abide by the rules of procedure for appeals.

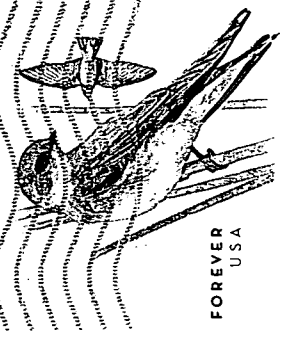

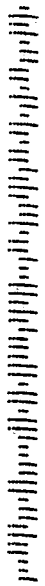
