MOTION TO SUPPLEMENT DESIGNATION OF MATTER

TO ALL PARTIES AND THE COURT OF APPEALS:

PLEASE TAKE NOTICE that the Appellant hereby moves the Court of Appeals, pursuant to Rule 209 and Rule 240 of the South Carolina Appellate Court Rules, to supplement the designation of matter previously filed with the Court. Specifically, the Appellant seeks to add additional pages to the previously designated trial transcript.

Appellate Court Rule 210(c) provides requirements for the inclusion of witness testimony in the record on appeal. Under the rule, certain pages of the testimony transcript must be included in the record in order to make clear the identity of “the witness, the phase of examination and the

name of counsel conducting the examination.” Rule 210(c). By way of this motion, the Appellant seeks to supplement the previously designated March 11 trial transcript in order to comply with Rule 210(c). Specifically, the Appellant seeks to add pages 2, 3, 59, 164, 254, and 301 to the designated March 11 trial transcript. These pages are intended entirely to provide the court context for its review of previously designated testimony.

The Respondents consent to the addition of these pages. A supplemental Designation of Matter, including these additional pages, is attached.


