Dear Ms. Kitchings:

I hope all finds you well. I wanted to address Pro Se Notice of Appeal that was received by your office from the above-mentioned individual.

As I mentioned to you previously, on **5/27/11** Mr. Moss was acquitted of the charge of murder. He was found guilty of three (3) counts of Discharging a Firearm into a Dwelling. **He did not appeal his convictions.** I have attached a copy of his SCDC information for your records.


According to the South Carolina Appellate Court Rules (SCACR) his appeal is untimely and should be dismissed. **He had ten (10) days to appeal a General Sessions conviction. He did not appeal.**

Additionally, under the Rules if he wished an appeal he had one (1) year from the date of conviction or 5/27/12 to file a Post Conviction Relief application to seek a belated appeal pursuant to White v. State. **He did not file a Post Conviction Relief application by 5/27/12.**

Based on the above-information, please advise if you wish me to correct the deficiencies in this Pro Se Notice of Appeal as outlined.
