

(Indictment No. 2014-GS-46-0390), Distribution of Heroin 3rd (Indictment No. 2014-GS-46-0391), Distribution of Heroin Proximity Park (Indictment No. 2014-GS-46-0392), PWID Clonazepam 2nd (Indictment No. 2014-GS-46-0495), PWID Crack Proximity School (Indictment No. 2013-GS-46-0497), Trafficking Crack 2nd (Indictment No. 2014-GS-46-0498) and Possession Marijuana 2nd (Indictment No. 2014-GS-46-0572). 


