Dear Rauch:

I am in receipt of your email requesting the above-referenced transcript held on September 4, 2012. I only did the jury selection process for this trial. Jo Rice reported the actual trial. Her mailing address is P.O. Box 561, Abbeville, SC 29620. Her email address is jrice@sccourts.org.

In my estimation the jury selection process lasted approximately 45 minutes, which would equate to approximately 45 pages. At a cost of \$3.25 per page, the total cost of the transcript will be \$146.25, plus postage and handling in the amount of \$5.00, for a total of \$151.25. 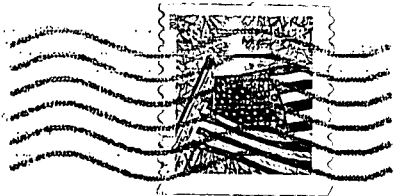
