



Hey Tommy – I was working on our Final Brief in this appeal and noticed 2 problems with the Record on Appeal. First, under Rule 267(c) provides that, "All papers or documents filed with the appellate court shall be typewritten or machine duplicated. Type size shall be standard 12-point or larger and double spaced on white bond paper of not less than twenty pound weight, 8 1/2 inches by 11 inches. With the exception of exhibits as provided in Rule 210(f), no photographic reduction of the Record on Appeal, brief or other paper is acceptable which reduces the size of the alphabet below that of pica type." Rule 210(f) only covers large scale maps and diagrams, etc. Dr. Van Dam's depo transcript is in the ROA in condensed version which violates Rule 267. The Court has had me re-file depositions in the normal font in the past.

Second, we designated APA pp. 214-222, but pages 214-218 appear to be missing in the ROA.

I just wanted to give you a heads up. You can move to amend the ROA and say that all parties agree that these changes should be made. That way, you can just file a supplement with the full-size Van Dam depo and the missing APA pages instead of having to file a whole new ROA.

Let me know how you want to handle this as our Final Briefs are due in early Feb.

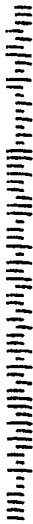
