RETURN TO THIRD-PARTY DEFENDANT GMAC MORTGAGE, LLC'S NOTICE
OF BANKRUPTCY FILING AND SUPPLEMENTAL SERVICING ORDER

In accordance with the Honorable Daniel E. Shearhouse's letter dated March 7, 2014, Third-Party Defendant, CitiMortgage, Inc. ("CitiMortgage"), hereby files and serves this Return to Third-Party Defendant GMAC Mortgage, LLC's Notice of Bankruptcy Filing and Supplemental Servicing Order ("Notice").
