
2. As Appellant's attorney has again had multiple hearings before the Workers Compensation Commission, Beaufort County Common Pleas, has had multiple depositions

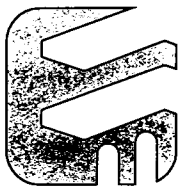



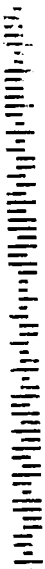
