

AFFIDAVIT

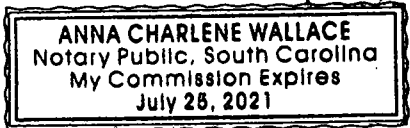
The undersigned, Brett Parker, first being sworn deposes and states as follows:



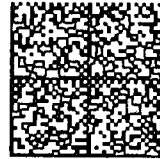
