Dear Ms. Kitchings:

The undersigned counsel received in yesterday's mail documents from Appellant George Glover identified as the Final Brief of Appellant, Certificate of Counsel, and Record on Appeal regarding the above-referenced matter. I write in reference to these documents to bring to the Court's attention certain deficiencies contained therein and to seek clarification of an accurate timeline for deadlines in connection with this matter, specifically the deadline for service and filing of Respondents' Final Brief.

While Appellant's Final Brief is deficient pursuant to Rule 267, SCACR, the most vexing problem is the filing Appellant has captioned as the Record on Appeal. Rather than including items listed in the parties' Designations of Matter to be Included in the Record on Appeal, Appellant has merely filed portions of Respondents' Initial Brief. Until this error is corrected, it will be difficult, if not impossible, for Respondents to calendar a valid deadline for compliance with Rule 211, SCACR.

For these reasons, we are requesting guidance from the Court, as well as a stay of any further deadlines pending resolution of these issues. Thank you for your assistance with this matter, and please contact me if you have any questions.


