Dear Ms. Kitchings:

This letter is to request a thirty day extension of time to file the Record on Appeal (or a corrected Record on Appeal). Because the Appellant-Respondent Town of Latta filed its Initial Reply Brief on February 20, 2014, the deadline for service of the Record on Appeal is today. However, it appears that counsel for the Respondents-Appellants have previously filed with the Court of Appeals a Record on Appeal which was filed prematurely because the briefing stage of the appeal was not even complete at the time.

In addition, there are significant problems with that Record on Appeal as filed by the Respondents-Appellants. It appears that the Respondents-Appellants have included in the Record on Appeal as filed *only those items that they designated*. There are hundreds of pages of trial testimony, exhibits and other items *as designated by the Town of Latta* that were not included in the Record on Appeal that has been filed. The Certificate of Counsel that was included in the Record on Appeal filed by counsel for the Respondents-Appellants is not correct.
