
**MOTION TO ACCEPT FILING OF



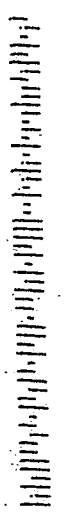
