


Dear Ms. Frierson:

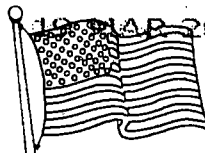
