

NOTICE OF APPEAL



Appellant further appeals from the ruling announced in open court on March 17, 2014, by the Hon. Garrison D. Hill, Circuit Judge, denying Appellant's motion for reconsideration.

An appeal was filed pro-se. A pro-se filing requesting reconsideration was mailed to the trial judge on March 21, 2013. No order appears to have been issued from that filing and a second pro-se filing was served on the Solicitor on April 1, 2013. An amended notice of appeal was filed by counsel. The appeal in this case was stayed and remanded for a hearing on Appellant's post trial motion. That Motion has now been ruled on by the Circuit Court but no written order has been served on counsel.

Appellant is filing this Notice so as to include in his appeal, the court's denial of his post trial motion.


