Dear Hon. John Few

I submitted an application for Post-Conviction Relief and it was filed on July 17, 2012 with the clerk of court in Berkeley County. I went to my hearing on January 13, 2014 and I was represented by Charles J. Brooks III of Sumter S. C. In his being appointed as my counsel I had numerous issues and conflicts with him and his representation. I first tried to get Mr. Brooks to visit me at the institution to discuss my case and he refused to visit stating "He does not go to prisons to visit inmates and he never came to visit. The first time I saw Mr. Brooks was five minutes before entering the courtroom. Mr. Brooks and I communicated through letters

and one phone conversation. In the first letter I wrote Mr. Brooks I told him everything leading up to my arrest and everything after my arrest. I also told Mr. Brooks about this police dept. that arrested me in that they were corrupted and they were doing things illegally and I also stated this during my plea hearing and it is in the transcript. The Federal Authorities are conducting an investigation and a lot of these officers have been fired and some facing jail time for misconduct and crimes committed by this department. I also wrote Mr. Brooks asking him to get some information for me that is very important to my case and he wrote back telling me lies and he refused to get the information. I sent Mr. Brooks motions to file on issues relating to my indictment and before filing he took a very important page out of this document and then filed an incomplete motion. I also sent a motion for Summary Judgment in which he did not file in a

timely manner, I also asked Mr. Brooks and my plea Counsel for copies of the recorded audio and of the interrogation tape and I still have not heard or gotten a copy of either recording. The interrogation tape will show no rights being read and intimidation to get confession. In her order of dismissal she states I was not credible if we look at what is going on with the Berkeley County Sheriffs Narcotics dept I ask are they credible because the ongoing investigation by the Federal Authorities has proven what I said in the transcript and what I am saying now and also the Solicitor Benjamin T. Shelton is no longer a prosecutor in the 9<sup>th</sup> circuit and I ask why he no longer works for the office of solicitor. I also have information from the clerk of courts office showing my indictment was not done according to statute 14-9-210 which governs the processor mandates the process for a legal true-bell indictment.

I asked Mr. Brooks in court and I wrote him asking him to do an objection to the order of dismissal and most of all to put in an 59c motion so the judge could rule on my issues and he refused and I was told by his office that a Notice of Appeal is the same as a 59c motion. In closing I was told to write you because you are about fairness and justice and to give you an idea or some knowledge of my case and that you maybe able to help me or give me some direction

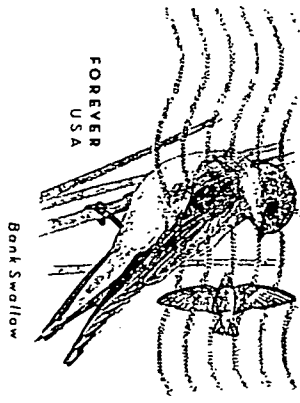
