
Petition to Substitute Counsel





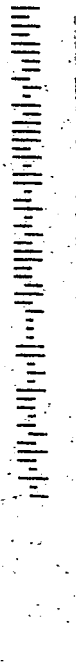
