


NOTICE OF SETTLEMENT



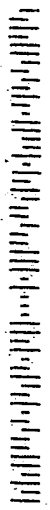
