Dear Mr. Shearouse;



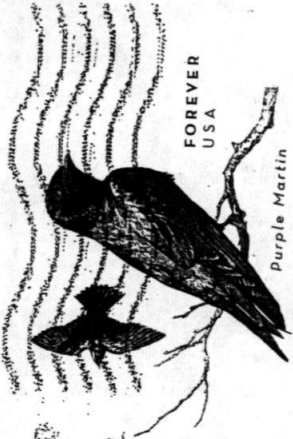
