They let me off lock up. I thought it was over and decided to let the issue die. But then they came back 7 mths later and locked me back up on the same (904) ^{Escape tool} charge I received back on 6/14/11. During that 7 mth period I lost all my paper work and copies of many many request to Major Sutton ^(Broad River) and warden Stevenson. Plus all my grievance copies. I was on lock up for 9 mths. So you can imagine how many requests I actually wrote to these people. Not, to say the least. Anyway, I need copies of all those requests.

It will prove my due diligence and all the aspects of my case if I can show the paper trail. Is there any possible way you could help me? I've tried writing the grievance office here at Lieber. The lady here has no benevolence towards my plight. If you will notice the dates on the returned request ~~of~~ from the (IGC) I have enclosed in this letter. You will notice a big time difference (she put) between my Step (1) and Step (2) receipts. I'm sure those dates are a mistake because the time between the two is almost 2 years. That is too long. That breaks policy. Regardless, I really need some help. I've written Columbia at HeadQuarts and have yet to receive a response from them and the (IGC) here is stonewalling me. Can you help me? Please.

Please send me this material as it is pertinent to my argument.



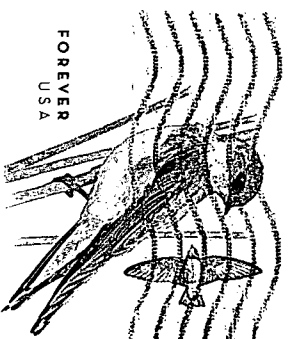
