

Pursuant to this Court's Order filed on August 9, 2013 ("Order"), *pro se* Appellant Daniel L. Junk respectfully submits this status update in the above referenced appeal. Debtors-in possession's ("DIP") Chapter 11 bankruptcy action remains pending, Case No. 13-55139, in the United States Bankruptcy Court, Southern District of Ohio, Eastern Division, before the Honorable John E. Hoffman. DIP's objection and counterclaim to CitiMortgage's Amended POC, adversary proceeding number 2:13-ap-02390, also is still pending.

All Parties have either answered or submitted Rule 12 motions that are being replied to or have been submitted to the court for decision. CitiMortgage and the other parties named herein continue to mislead the bankruptcy court by stating that there has been a final judgment on the validity of the debt, default and authority to enforce the debt already handed down in the South Carolina litigation. DIP has a motion to sell the Oldfield Property to a buyer for \$645,000. CitiMortgage objects to the sale and has made a motion to dismiss the bankruptcy and lift the stay. DIP's counsel is exploring sanctions against Security Connections for its repeated violations of the bankruptcy stay and this Court's above cited Stay Order as a result of its latest request that this Court issue an order of protection despite the stay in both courts.

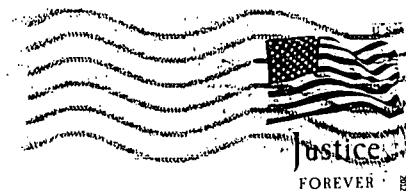
