

Pursuant to this Court's letter dated March 5, 2014, and received today, March 18, 2014,¹ and the Order filed on August 9, 2013 ("Order"), *pro se* Appellant Daniel L. Junk respectfully submits this status update in the above referenced appeal. Debtors-in possession's ("DIP") Chapter 11 bankruptcy action remains pending, Case No. 13-55139, in the United States Bankruptcy Court, Southern District of Ohio, Eastern Division, before the Honorable John E. Hoffman. DIP's objection and counterclaim to CitiMortgage's Amended POC, adversary proceeding number 2:13-ap-02390, also is still pending.

The Bankruptcy and Adversary Proceeding are still active. All Parties have either answered or submitted Rule 12 motions that are being replied to or have been submitted to the court for decision. CitiMortgage and the other parties named herein have moved for a stay of discovery. DIP has a motion to sell the Oldfield Property to a buyer for \$645,000. CitiMortgage objects to the sale and has made a motion to dismiss the bankruptcy and lift the stay. Security Connections has a pending request before this Court to issue an order of protection despite the fact that the stay remains in effect in both courts.

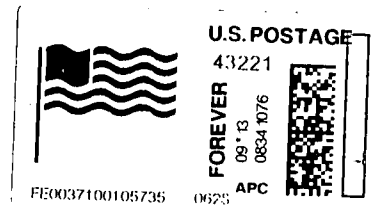
