**RESPONDENT'S MOTION TO
AMEND, SUPPLEMENT AND/OR MODIFY
A PORTION OF THE RECORD ON APPEAL**


Respondent hereby moves that the Record on Appeal be amended, supplemented and/or modified to include the entirety of Plaintiff's Exhibit #9 which was omitted from the Record on Appeal submitted to Respondent by Appellant on March 31, 2014. Respondent's Designation of Matter (Exhibit A attached) clearly designated the entirety of the exhibit consisting of thirteen (13) pages to be included in the Record; however, only four (4) pages of the exhibit was, in fact, included by Appellant and are numbered as pages 237-240. The omitted portion of the exhibit is relevant to Appellant's Issue III raised on appeal which challenges the Lower

Court's failure to compel arbitration and is necessary to enable Respondent to properly cite to that portion of the designated Record which supports the Lower Court's ruling that arbitration had been waived.

Respondent further requests instructions as to how to proceed to correct or fix the error in the Record but respectfully suggests that the exhibit in its entirety be designated and separately bound as a supplement to the Record and its pages designated as supplemental record (SR) pages 1-13 or that the exhibit in its entirety be separately bound and its pages numbered consecutively from the last numbered page of the record as presented by Appellant, to-wit: pages 265-277. To assist the Court in considering this motion a copy of Respondent's Designation of Matter to be Included in the Record on Appeal is attached as Exhibit A; Plaintiff's Exhibit #9 in its entirety is attached as Exhibit B; and pages 237-240 of the Record on Appeal served upon Respondent by Appellant are attached as Exhibit C.






On March 9, 2009, I was retained by the Plaintiff, John Walton, to represent him in an action against Mitchell L. Bagwell for breach of Lease Agreement.

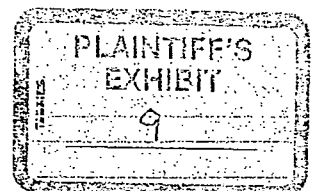
On March 9, 2009, I was retained by the Plaintiff, John Walton, to represent him in an action against Mitchell L. Bagwell for breach of Lease Agreement.
