NOTICE OF APPEAL





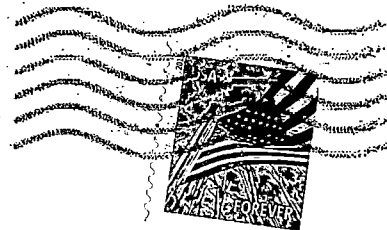
