selling or reselling this property is illegal

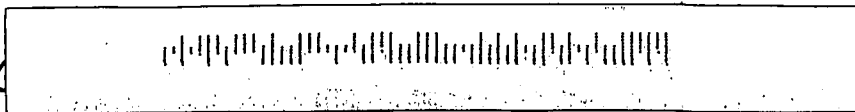

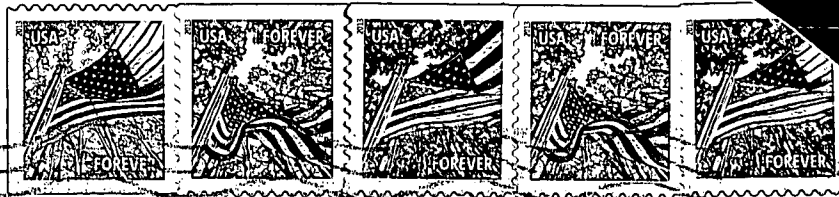
